U.S.G.A. Rules Govern All Play
Local Rules - Legacy Golf and Tennis Club

1. All concrete & coquina cart paths are deemed to be immovable obstructions
 - Free relief, nearest point plus one club length, no nearer the hole.
 2. Embedded ball rules are in effect anywhere in the general area.
 3. Play the ball as it lies (down) unless otherwise posted (check water station each day for play rules).
 4. Penalty areas are defined by red stakes or lines.
 5. Out of bounds is defined by inside points, at ground level of white stakes and curbs/edges of public roads. A ball which crosses a public road defined as out of bounds and comes to rest beyond that road is out of bounds, even though it may lie on another part of the course (Holes #3 & #11).
 6. A ball that crosses a penalty area and comes to rest on residential property (developed or undeveloped) or crosses a road is deemed to be out of bounds (Holes #1, 7, 9, 11, 12, 14 & 17).
 7. If a ball lies in or touches damage caused by sandhill cranes or non-burrowing animals through the green, the player may, without penalty, lift and clean the ball and drop it as near as possible to where the ball originally lay, which is not nearer the hole, avoids interference by the condition and is not in a hazard. Relief is for the lie of the ball only and not for stance or swing.
 8. A drop area is in place on Hole #16. The drop area is the forward tee box marked with a "Drop Area" sign.
- Stroke Play: If in doubt, play a second ball under Rule 3-3.
 Match Play: If in doubt, opponents may make claim under Rule 2-5.
